Moved by Bruckner that the minutes of the previous meeting, 6/19/17, be approved.

Public Comment:

Dave McCollum representing the Blanchard Lodge inquired about lowering their water/sewer rate. No action taken.

New Business:

Moved by Bauer to grant bid for DPW garage door/opener to Overhead Door for \$1700 and to TJ Kindt to wrap door frame in aluminum for \$200. Supported by Bruckner. Aye (6) Nay (0) Absent (1) Motion carried.

Moved by Bauer to pay dues of \$143.25 for 1 year with PROTEC, The Michigan Coalition to Protect Public Rights-of-Way. Supported by Tollison. Aye (6) Nay (0) Absent (1) Motion carried.

Mayor reported 2 instances of water pressure loss coming into town from Ida recently. He is addressing the issue.

Richards asked if residents are still allowed to take lawn waste to the City dump, as signs say no dumping allowed. There was an issue of people dumping furniture, etc. so a sign was posted. Mayor will look into different signage.

Old Business:

Moved by Bruckner to approve Ordinance #17-0002, setting the rate of compensation for clerk and treasurer, as printed. Supported by Tollison. Aye (6) Nay (0) Absent (1) Motion carried.

A letter will be drafted and mailed to all homeowners along the Safe Route to School route notifying them of removal of any trees and or other landscaping that will be removed by the City or a City hired contractor soon. Richards to assemble list of names/addresses.
