A Regular Meeting of the Council for the City of Petersburg was held on the above date.
The Meeting was called to order at 7:00 p.m. by Mayor, James W. Holeman

Minutes of the last meeting were presented to Council in printed form as recorded.
Moved by Bruckner that the minutes of the previous meeting, 5/7/18 be approved.

Invoices were presented to council in printed form by accounts: General fund- \$31,075.14; Police fund- \$24,029.08; Major St.-\$155.14; Local St.- \$155.12; Sewer fund- \$6,346.26; Water fund- \$23,897.32 for a total of \$85,658.06. New Business:

Bobbi Carroll representing the Dundee Area Rotary Club explained that the Rotary would like to make improvements to Perry Park. They will purchase paint and paint the benches and tables this year and will try to secure grant money up to \$4000 for new equipment next year. Bobbi will check back in the fall.

Moved by Tollison to purchase 3 office chairs. Supported by Bruckner. Aye (6) Nay (0) Absent (1)

Tollison reported arborist from Arrow Tree Service recommended Clifford Nault's tree be removed and gave a bid of \$1700. Tollison will contact them for a written estimate and to arrange removal.

Old Business:

Mayor has been in contact with attorney Fred Lucas regarding quit claim deed to Miller's for easement property and explained that the Safe Route to School project cannot proceed until that is completed.

Mayor reported the Bacome judgement to repay water tap fee has been recorded and a copy given to Summerfield Township.

Mayor reported a large pothole was discovered on Petersburg road and filled. It will be watched to see if it gets larger. There were some storm sewer issues on Chestnut that required jetting and will also be monitored. The water system asset management plan has been submitted to the state for review.

The mayor will keep on the blight issue on Petersburg road and if no action is taken by the homeowner, the DPW department may need to clean up the large pile and bill the homeowner.
