Mayor read letter from DEQ regarding mandatory water testing for 2 new substances. AECOM, a contractor, will conduct sampling and will contact the City sometime before 12/15/18.

Moved by Tollison to join PROTEC, Michigan Coalition to Protect Public Rights-of-Way, for one year trial with dues of \$143.25. Supported by Bauer. Aye (7) Nay (0) Absent (0) Motion carried.

Moved by Richards to raise all water rates 9% as of October 1, 2018 along with Bulk Water which will increase by \$1. Supported by Bruckner. Roll Call Vote. Aye (7) Nay (0) Absent (0) Motion carried.

Mayor reported Bobbi Carroll from Rotary Club would like to paint Perry Park benches/tables on Community Day with community involvement.

Mayor reported attorney Fred Lucas prepared Quit Claim Deed for Miller easement property but it needs revision per Tim Davis. Mayor will contact Mr. Lucas.

Mayor reported a resident would like to use City Hall for the filming of a screen play on Sunday, June 10 as the library community room was not available. Mayor will be present to supervise.

Mayor reported DPW has almost completed cleaning of storm sewers and they have gone to summer work hours, 6am-2:30pm. Also, Dave Kubiske of DAC is still working on water system improvement plan.

A Reflection Court homeowner asked to have cracks filled in that street. Mayor will assess and possibly seek a bid from Brian's Sealcoating.

Treasurer Goodin presented proposed budget amendments for this fiscal year for approval at next meeting.

Clerk Goodin will contact Monroe County Sheriff to obtain additional police protection for Community Days, July 13 and 14.

Tollison reported Mr. Nault's tree will be cut down June 11. She will be applying for the DTE tree planting grant soon.
