Public Comment:

Planning Commission chair, Stella Kirby, gave an update on the Master Plan survey which is due July 18.
She also asked that the parking spots on Center Street in front of Charlie's Repair Shop be restriped but not
to allow truck parking.

Outgoing Community Recreation Commission Director, Terri Nowak, introduced her replacement Nikki
Myshock who began today. She also advised council that the tackle football program for grades 1-6 will
now be flag football as the State no longer endorses tackle for this age group. They are trying to sell
equipment that is no longer needed. Terri will remain the supervisor for the preschool program on a
volunteer basis.

New Business:

City attorney Phil Costello was present to answer questions from council regarding medical/adult
use/caregiver marihuana.

Moved by Richards to approve paying dues in the amount of \$143.25 annual to PROTEC, the Michigan
Coalition to Protect Public Rights-of-Way. Supported by Bruckner. Aye (6) Nay (0) Absent (1) Motion
carried.

Old Business:

Moved by Richards to approve the bid from Southeastern Fencing in the amount of \$3,774 to replace the
south and east sides of fencing at Perry Park. Supported by Bruckner. Aye (6) Nay (0) Absent (1) Motion
carried.

Tollison reported that we received the \$750 from DNR/DTE tree grant. She also reported that Friends of
the Library will hold their raffle during Community Day as well as giving free cookies in honor of the
