Mayor will speak with Dundee township assessor about splitting out a parcel/value of it and to the building inspector about demolishing the house.

Tollison reported that Arrow Tree Service contacted her asking why they were not chosen to remove trees and she explained that their bid was much higher. They would still like to bid on future projects.
