Tollison advised that the tree trimming/removal needs to be completed by the end of October per the grant. Aardvark's quote for tree cutting was very high, Tollison getting second quote from John's Tree Service. We might only be able to remove 1 tree this year. Tollison also complained about loud 4-wheelers going up and down Madison Street in the evening. Deputy will need to address this if it continues.
