A Regular Meeting of the Council for the City of Petersburg was held on the above date.
The Meeting was called to order at 7:00 p.m. by Mayor Holeman.
Councilpersons present were Terri Bauer, Charles Bruckner, Fred Degner, Jenna LaRocca, Lawrence Schadewald and Joanne Tollison.

Invoices were presented to Council in printed form by accounts: General Fund-\$15,988.35; Police Fund-\$1,383.59; Major Streets-\$180.50; Local Streets-\$0; Sewer Fund \$15,023.33; Water Fund- \$2,526.39; for a total of \$35,102.16.

Monroe County Road Commission property was discussed. The Mayor will continue to make contact with them.
Saline and Wood St. water line repair still in need of continued work.
Wittman Dr. discussed. The project is *not* to be swept upon completion. Street Commissioner Degner has been in contact with the Road Commission Re: the Contract.

The wages and days off were discussed for the 4 full time hourly employees at this time.
Moved by Bruckner that Council approve a "final offer" to the 4 full time hourly employees be giving a 2% wage increase for fiscal year 2012/2013 starting July 1st and a 1% wage increase for fiscal year 2013/2014 also effective July 1st. Supported by Degner. Aye (6) Nay (1) Haller Motion carried.

The library will be landscaping to attract butterflies.

Moved by Bauer that Council approve making trees available for the Division Street Condominiums upon request providing it's approved by the Condo's Association. 1 tree per household and each property needs to meet the City' criteria for planting. Supported by Schadewald. Aye (7) Nay (0) Motion carried.

Councilman Haller attended a Summerfield Recreation meeting and shared with Council that they discussed an interest in a Donation of Equipment for Perry Park.

The Treasurer provided a revenue expenditure report to Council for review.
