A Regular Meeting of the Council for the City of Petersburg was held on the above date.
The Meeting was called to order at 7:00 p.m. by Mayor, James W. Holeman.

Invoices were presented to council in printed form by accounts: General fund- \$28,200.19; Police fund- \$28,646.40; Major St.-\$0; Local St.- \$0; Sewer fund- \$8,540.76; Water fund- \$25,265.25 for a total of \$90,652.60. New Business:

Insurance agent Brian Hughes presented quotes for DPW medical coverage and explained that the current plan will increase 10.8%, but it had decreased 2.11% last year. Prior to this meeting he met with the mayor and DPW to go over options. DPW would prefer to keep current plan.

Moved by Bauer to approve the renewal of current medical coverage for DPW department with HAP, effective December 1, 2022. Supported by Bruckner. Aye (5) Nay (0) Absent (2) Motion carried.

Moved by Bauer to approve spending up to \$65,000 for new truck with plow for DPW department. Supported by Tollison. Roll call vote. Aye (5) Nay (0) Absent (2) Motion carried.

Tollison reported the \$800 DTE tree grant was awarded to the City and 10 trees will be planted in early November.

Employee Reports:

Clerk Goodin reminded council that the next meeting will be on Tuesday, November 1, 2022, to avoid election week. Goodin also reported that Lume is only renewing one adult-use provisioning center cannabis license, instead of three.
