Planning Commission chair Stella Kirby reported on recent meeting with McKenna regarding updating the Master Plan. McKenna representative will attend the May 28 Planning Commission meeting. A joint council/planning meeting will be held on September 16 to review the final draft.

Mayor reports landowners are considering selling a small parcel of land on Ida West in Raisinville Township for the pump station, upon approval from the Township.

**Council Reports:**

Bauer reminded council that we need to secure sheriff coverage for Community Days, July 12 & 13. Clerk will contact sheriff department. Bauer asked if nets on basketball court can be replaced as the ball gets stuck. Mayor will get them replaced.

Richards asked that the owner of the tow truck parked at Center and Wood Streets be asked to park back away from the road as it is difficult to see around it when turning onto Center. Richards also inquired about the visibility of police in the City per comments from residents. Mayor will contact sheriff department.

Cilley asked council to reconsider permanently removing the stairs to Fernstrom Park as she has spoken to the Rotary about funding their replacement. Mayor and Cilley will meet soon to look at options for moving the stairs to a less sloped area, requiring less stairs and material.

**Employee Reports:**

Treasurer reported she is working on the budget. The City now accepts all major credit cards for payment of water/sewer and taxes with a processing fee passed onto the credit card holder.
