A 20 question survey will be available June 18-July 18, both paper and online. McKenna will have a booth during Community Day with PC members present also. The current timeline is: 7/23-Hunter present PC with Master Plan draft. 9/16-Joint PC/Council meeting to review final draft. 60 day review. 11/26-Final draft presented to PC. 12/2-Council approval of final draft. (possible additional PC meeting in October)
