A Meeting of the Council for the City of Petersburg was held on the above date.  
The Meeting was called to order at 7:00 p.m. by Mayor, James W. Holeman

Moved by Tollison to approve the agenda as printed. Supported by Cilley. Aye (6) Nay (0) Absent (1) Motion carried.

**New Business:**

Planning Commission chairperson Stella Kirby highlighted the final technical review of the zoning book by McKenna. Total cost to rewrite the book if done all at one time, \$36,000. \$4000 to produce a Permitted Use Table.

Moved by Bauer to amend the current Planning Commission budget from \$500 to \$3000 to allow for McKenna to produce a Permitted Use Table at a cost not to exceed \$4000. Supported by Cilley. Aye (6) Nay (0) Absent (1) Motion carried.

Moved by Bruckner to accept the resignation of electrical inspector Louis Duby effective 9/15/21. Supported by Bauer. Aye (6) Nay (0) Absent (1) Motion carried.

Mayor to contact the State electrical department to find out qualifications needed for electrical inspector.

Moved by Cilley to allow Lume Cannabis to park food trucks on Tandem Court near their parking lot for a 1 year anniversary celebration, September 3-6, provided they advise the fire department. Supported by Tollison. Aye (6) Nay (0) Absent (1) Motion carried.

**Old Business:**

Mayor reports the stairs to Fernstrom Park are unsafe and will be disassembled by the DPW department. In their place, the plan is to install at least a 20' 42" culvert down the hill closer to the wastewater plant that pedestrians and golf carts could cross over to the park.

**Council Reports:**

Tollison suggested that there be some sort of ribbon cutting on the Safe Routes to School sidewalks. Cilley will contact Summerfield Schools to see if it can be incorporated into their Welcome Back and Bell Dedication on August 31.
